

# TECHNICAL ASSISTANCE FOR THE IMPLEMENTATION OF CIVIL SOCIETY DIALOGUE AND CIVIL SOCIETY SUPPORT PROGRAMMES

## BERLIN-GERMANY STUDY VISIT INFORMATION NOTE 15 - 18 May 2023











## 1. THE CIVIL SOCIETY DIALOGUE BETWEEN TÜRKİYE AND EUROPEAN UNION GRANT PROGRAMME

"The Civil Society Dialogue between Türkiye and the EU" (CSD) is a grant programme that aims to bring together civil society organizations in Türkiye and the EU around common issues to exchange knowledge and experience and to build a lasting dialogue. Civil Society Dialogue ensures that EU norms and good practices are brought to our country through the cooperation and partnerships developed between civil society organizations in Türkiye and the EU within the scope of the areas related to the EU acquis. Through the partnerships and networks established in many thematic areas within the framework of dialogue projects, public opinion about the future enlargement policies of the EU is shaped, mutual understanding between Türkiye and the EU is encouraged, and the common working culture and cooperation are reinforced.

The Civil Society Dialogue Programme is co-financed by the European Union and the Republic of Türkiye within the scope of the Instrument for Pre-Accession Assistance (IPA I and II) allocated to our country with the recognition of its candidate status. As the lead institution of the civil society sub-sector, the Directorate for EU Affairs is responsible for the overall coordination and monitoring of the project. The Directorate for EU Affairs, Project Implementation Department is responsible for the implementation, management, sustainability and monitoring of projects that have been allocated grants. The CFCU (Central Finance and Contracts Unit) is the contracting authority of the programme and is responsible for the administrative and financial implementation of the Grant Programmes.

Since 2008, the programme has provided approximately 53,2 million euro to 418 projects carried out in various fields within 6 different periods. As a result of these projects 117 networks and platforms have been created between Turkish and European civil society organizations (CSOs). 2.057 CSOs from Türkiye and EU countries have joined in these networks and platforms.

At total 502civil society organisations have taken part in those related projects as lead and partner in 28 countries such as Germany, Austria, Belgium, Bulgaria, Czech Republic, Denmark, Estonia, Finland, France, Croatia, Holland, Ireland, Spain, Sweden, Italy, Latvia, Lithuania, Hungary, Malta, Poland, Portugal, Romania, Slovakia, Slovenia, Greece as well as in Bosnia Herzegovina, North Macedonia and United Kingdom.

#### THE FIRST PHASE OF THE CIVIL SOCIETY DIALOGUE: CSD-I (2008-2009)

A total of 19.3 million euro was provided for 119 projects developed by actors who have a significant impact on the dialogue between the EU and Türkiye, such as municipalities, professional organizations, universities, and youth organizations, together with their European partners. During this period, 23 networks and platforms have been created between Turkish and European civil society organizations (CSOs). 236 CSOs from Türkiye and EU countries have joined in these networks and platforms.

#### THE SECOND PHASE OF THE CIVIL SOCIETY DIALOGUE: CSD-II (2010-2012)

In the second phase of the programme implemented under the themes of "Culture-Art" and "Agriculture-Fisheries", 5,2 million euro was provided for partnership projects and nearly 300,000 euro was transferred to small-scale activities developed in various themes under the micro-grant component. Within the scope of CSD II more 15 thousand experts and sector employees have convened as well as over 20 thousand people has been reached through the activities such as conferences, trainings, exhibitions and on forth. At total 97 projects have been implemented.

#### THE THIRD PHASE OF THE CIVIL SOCIETY DIALOGUE: CSD-III (2014-2016)

The third phase of the programme witnessed partnership projects of civil society organizations from Türkiye and the EU working in the field of "media" and "political criteria". Grant support of 2 million euro was provided to 15 dialogue projects developed by media organizations that will play an active role in raising public awareness on the European Union, its values, and what EU membership will bring both to our country and the European Union.

In the scope of CSD-III, a grant support of 4,6 million euro was provided to 36 partnership projects developed in the priority areas of human rights, anti-discrimination, democracy and the rule of law in order to ensure a better understanding of reforms implemented in the EU accession process and their results and to support the realization of these reforms with the participation of civil society organizations. The third phase of the Civil Society Dialogue was successfully completed with 51 projects as a result of the withdrawal of 4 projects from implementation.

#### THE FOURTH PHASE OF CIVIL SOCIETY DIALOGUE: CSD-IV (2015-2017)

In the fourth phase of the Civil Society Dialogue Programme 10,5 million euro grant support was provided to 78 partnership projects carried out in nine policy areas: Environment, energy, consumer and health protection, justice, freedom and security, right of establishment and freedom to provide services, regional policy and coordination of structural instruments, business and industrial policy, agriculture and fisheries and education.

#### THE FIFTH PHASE OF CIVIL SOCIETY DIALOGUE: CSD-V (2019-2020)

A total of 6,9 million euro was provided for 40 dialogue projects to be implemented jointly by CSOs from Türkiye and EU member states/EU candidate countries within the scope of the fifth phase of the Civil Society Dialogue Programme. The projects that received grants focused on dialogue development and cooperation, while also working on social issues for disadvantaged groups such as the disabled, the elderly and the refugees. The projects have been implemented in fields such as gender equality, education, health, agriculture, food and environment. 32 of the coordinator beneficiaries of the projects were from Türkiye, 7 of them were from EU member states and 1 of them was from Bosnia and Herzegovina, which has the status of a candidate country.

#### THE SIXTH PHASE OF CIVIL SOCIETY DIALOGUE: CSD-VI (2021-2022)

The sixth phase of the programme (CSD-VI) began in April 2021. Approximately 4,7 million euro grant support is provided to 33 projects to be carried out by civil society organizations from Türkiye and the EU on activities organized for awareness-raising on Türkiye and the EU accession process as well as cooperation, partnership, and networking in fields relevant to the EU acquis. The projects have been completed in 2022.

#### 2. A BRIEF OVERVIEW TÜRKİYE - EU CIVIL SOCIETY DIALOGUE NETWORK

To be a facilitator of an effective civil society dialogue that contributes to the development of EU-Türkiye relations.

#### Mission:

To create a network that will strengthen cooperation and dialogue between non-governmental organizations in the EU and Türkiye and to act in this sense.

#### **Key Activities:**

- Organization of coordination meetings between the members of the network (at least every 2 months, at least 6 meetings per year),
- Preparation of the annual business plan,
- Development and implementation of projects through consortia formed by the members of the network,
- Organization of study visits abroad and participation in study visits abroad,
- Close follow-up of the IPA process, involvement and participation in relevant meetings (IPA Committee, Sectoral Monitoring Committees, Project Steering Committees, etc.),
- Closely follow the Union programs in which Türkiye participates, contribute and participate in the relevant meetings,
- Participate in international civil society activities at the EU level,
- Investigate and participate in mechanisms that can enhance civil society participation in EU-Türkiye relations,
- Follow the work of the Joint Consultative Committee of the EU Economic and Social Committee and build relations with the members of the EU wing,
- To create network-like structures through non-governmental organizations at the EU level and to contact higher-level organizations,
- To advocate for the establishment of the EU-Türkiye Civil Society Forum,
- Lobbying the EU and Türkiye to strengthen civil society participation in EU-Türkiye relations,
- To form opinions and advocate for the improvement of EU-Türkiye relations.

#### Membership structure:

Non-governmental organizations that meet the established criteria are unanimously admitted to the Network upon the proposal of at least two founding members.

#### Criteria of the membership:

- Working and project experience in developing cooperation and dialogue with nongovernmental organizations in the EU,
- The compatibility of the institution's activities with fundamental human rights and the common values of EU and Türkiye,











 Commitment to an environment in which effective, participatory, sustainable, transparent, gender-respecting and democratic relations and partnerships are established between EU and Türkiye,

#### **Coordination of the Network:**

The coordination of the network in 2023 will be carried out by the three institutions designated for implementation under the responsibility of the main coordinator. In principle, it is envisaged that the role of NGO coordinator will be performed and rotated by one of the network members each year. However, this period can be extended up to 2 years if necessary. Institutions that are nominated themselves or institutions that are nominated, are elected by majority vote with the participation of all members.

#### Role of the Executive Team:

Organize coordination meetings,

Facilitate collaboration and communication among members, developing the draft annual business plan,

Establishment and implementation of membership processes.

#### Statement on the Launch of the Türkiye-EU Civil Society Dialogue Network

The world is in a period when debates on the future of democracy are flaring up, aspirations for rights and freedoms and conflicts over gender equality are increasing, and problems such as the climate crisis, the war in Ukraine, the economic crisis, the energy crisis, growing populism, the food crisis and rising inequality are creating new crises. At this time, it is of great importance that relations between Türkiye and the EU are once again at the top of the agenda. Reviving Türkiye-EU relations will also go a long way in overcoming these crises. However, for relations to be revived and the integration process to regain momentum, the culture of partnership, cooperation and collaboration between Türkiye and the EU must be rebuilt. This rebuilding process can put Türkiye's EU membership back on the agenda of the EU and the Turkish public. In this process, it should be emphasized that Türkiye is a historical and cultural part of Europe and that a common future should be built together.

The revival of our country's EU reform process, especially the protection of fundamental rights and freedoms, the strengthening of participatory democracy and the restoration of the rule of law, is the first step that needs to be taken in this process.

Looking at the last 20 years of EU-Türkiye relations, it can be said that while the participation of our country's civil society in EU-Türkiye relations has reached a significant level, the participation of civil society in the structural and institutional level of relations has remained limited. Involving civil society in the process with structured and meaningful means of participation is crucial for redefining EU-Türkiye relations. Moreover, non-governmental organisations in the EU and Türkiye need to come together more and be part of the solution in this time of crises we are in. For this reason, it is necessary to continue and strengthen the civil society dialogue between the EU and Türkiye.











For this reason, we, the following non-governmental organisations, will begin to jointly build a network that will strengthen cooperation and dialogue between the EU and non-governmental organisations in Türkiye and increase the role of civil society in EU-Türkiye relations. We are pleased to announce to the public that we will continue our efforts to establish a civil society dialogue network between Türkiye and the EU.

With this structure, we aim to become a platform that strengthens cooperation and dialogue between the EU and non-governmental organisations in Türkiye in the medium term and enhances the role of civil society in Türkiye-EU relations.

## Türkiye-EU Civil Society Dialogue Network Members of the Network

#### 1. Economic Development Foundation (IKV)

IKV is a non-governmental research organization specialised on the EU and Türkiye-EU relations. IKV was established with the initiative of Istanbul Chamber of Commerce and Istanbul Chamber of Industry on the 26th November 1965, two years after the entry into force of the Ankara Agreement, to inform Turkish business world and Turkish public about European integration and Türkiye-EU relations. Since its establishment, IKV has become an effective expert organisation on the EU and Türkiye-EU relations both in Türkiye and in the EU, through its publications, seminars, lobbying activities and the close cooperation with foreign and domestic institutions. IKV Brussels Office has been conducting IKV's relations with the EU institutions since 1984. Briefly, IKV gives information regarding the EU to Türkiye and regarding Türkiye to the EU.

Along with the two founding organisations, Istanbul Chamber of Commerce and Istanbul Chamber of Industry, currently, IKV is supported from trustees representing the business world and sectors such as the Union of Chambers and Commodity Exchanges of Türkiye (TOBB), Turkish Exporters Assembly (TIM), Turkish Industry and Business Association (TUSIAD), Istanbul Textile and Apparel Exporters' Association (IHKIB), Istanbul Commodity Exchange (ITB), Turkish Bank Associations (TBB), Confederation of Employers' Union of Türkiye (TISK) and Kocaeli Chamber of Industry. In addition to the members of the trustees, more than 30 organisations support the activities of IKV.

#### 2. The Women Entrepreneurs Association of Türkiye (KAGIDER)

The Women Entrepreneurs Association of Türkiye (KAGIDER) is a non-governmental organization aimed at strengthening women entrepreneurs with 420 members representing 8% of the Turkish economy. KAGIDER's goal is to strengthen women not only economically but also socially and politically. KAGIDER has made its mission to support women entrepreneurship because it believes that women entrepreneurs have a strong impact on reversing the trends of gender inequality and women's economic exclusion. In addition, the goal is to bring attention to the societal contributions of women entrepreneurs in maintaining gender equality within society. In partnership with national and international public, private and civil organizations, KAGIDER has developed and continue to work on several projects











and activities. Active globally, KAGIDER is the founding association of W20, has a focal point in Brussels, has consultative status for UN ECOSOC, member of FCEM, AFAEMME, WEP and is one of the five founding members of Balkan Women Coalition.

KAGIDER follows 8 strategies in carrying out its activities:

- Increase the number of women in the business world and promote women entrepreneurs;
- Provide trainings and mentoring to women in entering the business world and becoming an entrepreneur
- Spread the impacts of KAGIDER's activities across Türkiye.
- Support the legal base for the development of an ecosystem for women entrepreneurship while providing a road map for financial access
- Support KAGIDER members in growing their businesses
- Encourage and support young women in their entry into the business and entrepreneurial world while continuing their education
- Raising awareness about KAGIDER
- Become a reference point for supporting women entrepreneurship and developing the content and technological activities in women's careers at the national and international level.

#### 3. Association of Civil Society Development Center (STGM)

Civil Society Development Center (Sivil Toplum Geliştirme Merkezi Derneği - STGM) was founded in the year 2004 by a group of opinion leaders and activists who believed in the importance of civil society for the development of participatory democracy in our country.

The fundamental purpose of STGM is supporting civil society organizations, which are the voices of citizens and essential actors of democracy, towards being strengthened and capable of realising more effective actions. Therefore, although providing assistance to all structures within civil society, STGM gives priority to the organizations that employ rights-based approach. The priority target group of STGM comprises of the civil society organizations that deal in the fields of gender, children, human rights, youth, environment, handicapped rights and cultural rights/culture-arts.

Capacity building supports come at the top of the study areas dealt with by STGM. These capacity-building studies take on forms that align with the needs that change in time from common training programmes to the provision of legal assistance to organizations, and from institutional guidance studies to empowering civil networks and cooperation. Policy advocacy is yet another study area which is on the agenda both in the context of the own freedom of organizing for STGM and in the context where STGM develops programmes for empowering other organizations. Our communication studies, through which we have tried out many firsts in civil society during the last 20 years, aim for increasing the visibility of civil society organizations as well as aiming to publicize the efforts of STGM.











STGM has been conducting its studies mainly though projects within the scope of instrument for pre-accession financial cooperation and civil society supported by the European Union since the year 2004. On the other hand, STGM carries out closely cooperated actions with public institutions.

#### 4. Türkiye Europe Foundation (TAV)

Türkiye Europe Foundation (TAV) is a civil society organization based in Istanbul with a national scope, which was founded on 13 December 2000 and became a legal entity on 17 January 2001. Within the scope of Türkiye's journey towards full membership to the European Union, the foundation works to improve the capacities of non-governmental organizations, to develop public and civil society dialogue, to stimulate democratic and active participation of citizens, and to raise awareness about active youth participation. The foundation is mainly collaborated and financed by external donors such as the EU, UNESCO, Sweden Consulate, Netherlands Consulate, and the private sector; and it has extensive experience in EU-funded project management. TAV executes many national and international programs, projects and events by collaborating and partnering with a wide range of organizations including local, regional and national authorities as well as public institutions, universities, companies and NGOs.

TAV defines its main duties as follows:

- Working in dialogue and cooperation with other non-governmental organizations;
- To support public institutions in their reforms and studies in the fields of democratization of ürkiye and full membership to the European Union.

TAV carries out its activities in three main areas:

- EU Studies, Türkiye EU Relations and Türkiye's Full Membership to the EU · Public Civil Society Dialogue and Cooperation
- Youth Studies

#### 5. Turkish Enterprise and Business Confederation (TURKONFED)

TURKONFED (Turkish Enterprise and Business Confederation) is a non-governmental and nonpartisan business organization, aiming to contribute to the development of regional, sectoral and national economic policies. TURKONFED was established in 2004 as a nation-wide confederation, representing 6 federations and 69 associations. Today, TURKONFED represents 30 federations and 300 associations with more than 50,000 company as members. TURKONFED is member of SME united, which is the association of crafts and SMEs in Europe representing over 22 million SMEs from 30 European countries. In this respect TURKONFED is a bridge between the Turkish business world and the European Union. In addition,











TURKONFED has members from across the globe that gather under the platform TURKONFED International.

TURKONFED has three main functions: Policy design/advocacy, capacity development and business development. The working areas and activities of these three functions are determined through TURKONFED Commissions: Economic Development & Sustainability Commission, Commission on Women in Business World, Regional Development Commission, Sectoral Development Commission, Youth, Education & Entrepreneurship Commission, Digital Transformation Commission, Green Transition Commission and finally, Access to Finance Commission.

After having a Bachelor's Degree in the Department of International Relations at Middle East Technical University in 1999, he completed the Master's Programme on the European Union Economy at the EU Institute of Marmara University.
